3. PROFILE OF SKILLS AND COMPETENCES

- Design and construct tiled stoves and plastered stoves, ovens, hand-crafted kitchen stoves and fireplaces
- Plan, construct and install hot air central heating installations, ventilation installations, electric storage heating, oil, gas and solid fuel burners, central heating oil supply systems and chimneys
- Install heating and chimney inserts with hot water heat exchangers including regulation controls
- Plan and manage work processes, monitor and evaluate work results and apply quality assurance measures
- Check, adjust and commission stoves and air heating installations
- Provide customer service, carry out inspections and maintenance works
- Advise customers on products and services and provide customer support whilst according due consideration to technological, ecological and economic aspects
- Deliver stoves and air heating installations and systems to customers and provide instructions in the use of plants.

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE (1)

Builders of stoves and air heating systems mainly work for craft trade companies specialising in tiled stove, stove and fireplace construction both on site and in the workshop. They are also in demand as skilled workers within the relevant retail trade and manufacturing industry.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Final examination administered by the competent body:</p> <ol style="list-style-type: none"> 1. after completion of dual training in a company and at part-time vocational school (normal procedure) 2. after retraining in a recognized training occupation 3. as an external examination for working people without formal vocational qualifications or persons who have been trained at full-time vocational schools or other vocational training institutions
<p>Additional information</p> <p>Entry requirements: Entry requirements are not governed by legislation; as a rule, young people are admitted after completing (nine or ten years of) general education.</p> <p>Duration of training: 3 years.</p> <p>Training in the "dual system": Teaching of the knowledge, skills and competences needed for an occupation is based on the typical requirements of work and business processes and prepares the trainees for a specific job. The training is provided in a company and at part-time vocational school: In the company, the trainees acquire practical skills in a real working environment.
